courtiers Overview



The Courtiers Investment Grade Bond Fund is primarily focused on producing long-term growth and income for investors.

The Courtiers Investment Grade Bond Fund: will invest in investment grade government and non-government fixed and variable interest rate securities worldwide. Investment grade is a rating which is BBB or higher from the rating agency Standard & Poor's or the equivalent rating of another internationally recognised rating agency such as Fitch or Moody's. The Fund may also invest in other transferable securities such as units/shares in investment funds, warrants, cash and near cash and deposits. Derivatives (investments whose value is linked to another underlying investment such as shares or performance of a stock exchange) may be used to reduce risk or cost and/or to generate extra income and growth.

The fund is typically expected to hold between 8 and 15 investment grade government and non-government fixed and variable interest rate securities globally.

The fund was launched on 30 November 2015. The fund is managed on a co-manager basis. Gary Reynolds, CFA, has co-managed the fund since inception. Jacob Reynolds, CFA, was appointed co-manager in March 2021.

courtiers Fund Objectives




The fund seeks to achieve a long-term total return comprised of income and capital growth. The objectives of the fund are detailed fully in the prospectus.


COURTIERS Fund Construction

courtiers Security Selection




The Investment Team will consider all issuers with an Investment Grade Rating. The ratings are determined by internationally recognised rating agencies including Standard & Poor's, Moody's and Fitch.

There is a preference for government, supranational or highly rated corporate bonds. The fund may acquire issues from both the primary and secondary markets.

There are no targets or limits with regard to sectors and/or geographies. The fund is subject to the applicable regulatory limits.

The Investment Team endeavours to ensure the fund carries limited risk with regard to the following:
